#### **Representative Experience:**

- Represents multiple national and international Prime Contractors in both contentious and non-contentious
  matters related to infrastructure construction. Contentious work includes negotiation, mediation, arbitration,
  and litigation with public owners as well as subcontractors and suppliers related to payment, delays, scope of
  work, and defective design and construction. Non-contentious work includes analysis and negotiation of
  contracts.
- Represented general contractor in a bet-the-company lawsuit involving delay and defective work claims by the owner exceeding \$13 million, and wrongful termination claims by the general contractor of nearly \$8.5 million. The case involved as many as 50 other parties.
- Defended general contractor and individual indemnitors in claims by surety for almost \$7 million related to bond claims. As part of a favorable settlement, the clients paid a small fraction of the claimed damages.
- Represented general contractor seeking payment for extended general conditions and unapproved change
  orders in arbitration against a project owner. The owner sought damages for delays and defective
  construction. The case was resolved with a significant payment to the client.
- Represented general contractor who entered into more than 50 contracts to perform emergency services work as a result of hurricane damage on the coast. The disputes arose with subcontractors and related entities; all were successfully resolved in litigation for the contractor.
- Defended prime contractor against owner claims related to defective construction of retaining walls designed by the Texas Department of Transportation.
- Represented landscape architect in arbitration against project developer for payment. The Arbitrator awarded a full recovery, including damages, and legal costs, to the landscape architect.
